MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE PICO WATER DISTRICT

A Regular meeting of the Board of Directors of the Pico Water District was held in the District's Boardroom located at 4843 South Church Street, Pico Rivera, California, on Wednesday, January 13, 2021 at 6:03 p.m.

The District's Secretary/General Manager, Mr. Mark J. Grajeda proceeded with the roll call of the attending Board members. Present from the beginning of the meeting were President David R. Gonzales, while Director Pete Ramirez, Director Robert Martinez, and Vice President Victor Caballero participated telephonically, in adherence to social distancing. Mr. Jim Ciampa, Legal Counsel for the District participated electronically and Pico Rivera City Councilmember Andrew Lara participated telephonically.

President Gonzales presided over the meeting and Councilmember Lara led everyone in the Pledge of Allegiance.

Vice President Caballero gave the invocation.

President Gonzales proceeded to the next item on the Agenda, Public Comments. Councilmember Lara informed the Board that the Pico Rivera City Council compared costs of onsite PFOS/PFOA treatment and imported water from Metropolitan Water District/Central Basin Municipal Water District and found there was a significant savings for onsite treatment of the groundwater wells.

President Gonzales proceeded to the adoption of the Agenda. Director Ramirez made the motion to adopt the Agenda and Vice president Caballero seconded the motion. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the approval of the Consent Calendar. Director Ramirez informed the Board that he cannot vote on item 6A – consider December 2, 2020 Board Minutes as he was not a Board Member at that time. President Gonzales made the motion to approve item 6A – December 2, 2020 Board Minutes and Director Martinez seconded the motion. The General Manager announced that the motion passed by roll-call vote, 3-0. Continuing with the approval of the Consent Calendar, Director Martinez made the motion to approve items 6B, C, D, and E and President Gonzales seconded the motion. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the next item on the Agenda, consider establishing the process to fill the Board vacancy left by Director Andrew Lara's election to the City of Pico Rivera Council. Legal Counsel explained to the Board the requirements for vacating the seat, reporting the vacancy, posting the vacancy and the options to fill the vacancy. Those options are to hold an election, or the Board could appoint someone or the Board could take no action and then have the City of Pico Rivera appoint someone. The General Manager reviewed with the Board the steps

the District will take to post the vacancy – the District planned to place a notice in the Whittier daily News, post the vacancy on the District's onsite bulletin board and on our website, post on our in social media site, post a notice at the local post office, post a notice on the senior center Board and on the local library Facebook. After a brief discussion, it was reiterated that time is of the essence for the Board to act as they are constrained by a deadline of February 16, 2021. Director Caballero made the motion to approve the procedures as outlined by Legal Counsel and the General Manager and Director Ramirez seconded the motion. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the next item on the Agenda, consider joining the Public Water Agencies Group to file for a grant from the Hazard Mitigation Grant Program. The General Manager reviewed the staff report outlining the background and purpose of the Hazard Mitigation Grant Program. The group was planning to seek a maximum amount of \$250,000 and would need to contribute 25% which would be split amongst the members and should not cost the District much over \$6,000. Legal Counsel informed the Board that currently there are 10 PWAG members participating as the other members of PWAG have already prepared their own Hazard Mitigation Plan. After a brief discussion Director Caballero made the motion to approve and Director Martinez seconded the motion. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the next item on the Agenda, consider proposal from Kabbara Engineering to prepare engineering plans to extend the eight-inch mainline in Burma Road approximately 400 lineal feet to Rosemead Boulevard. The General Manager reviewed with the Board the staff report outlining the need to replace the existing four-inch main, and extend the existing eight-inch main the length of Burma to Rosemead Boulevard. Vice President Caballero made the motion to approve and Director Martinez seconded the motion in the amount of \$10,615.00. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the next item on the Agenda, General Manager's report. Work in Beverly Blvd. is moving along very well; also the General Manager informed the Board that there is an old asbestos line currently in the sidewalk south of Norm's Restaurant that he is suggesting the District replace and will bring back for consideration at the next Board meeting; currently District staff is working on closing out the fiscal year and readying reports for the coming year to include CivilTec Engineering going forward on the Water Master Plan; having AKM present an update at the next board meeting on the PFAS/PFOA engineering plan and discuss the capacity fee charge.

President Gonzales proceeded to the next item on the Agenda, Legal Counsel report. There was none.

President Gonzales proceeded to the next item on the Agenda, Director's request for future agenda items. There were none.

President Gonzales proceeded to the next item on the Agenda, Director report on meetings attended. There were none.



MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE PICO WATER DISTRICT

A Regular meeting of the Board of Directors of the Pico Water District was held in the District's Boardroom located at 4843 South Church Street, Pico Rivera, California, on Wednesday, January 20, 2021 at 6:05 p.m.

The District's Secretary/General Manager, Mr. Mark J. Grajeda proceeded with the roll call of the attending Board members. Present from the beginning of the meeting were President David R. Gonzales, while Director Pete Ramirez, Director Robert Martinez, and Vice President Victor Caballero participated telephonically, in adherence to social distancing. Mr. Jim Ciampa, Legal Counsel for the District participated electronically. Pico City Councilmember Andrew Lara participated telephonically.

President Gonzales presided over the meeting and Vice President Caballero led everyone in the Pledge of Allegiance.

Director Martinez gave the invocation.

President Gonzales proceeded to the next item on the Agenda, Public Comments. Ms. Camacho-Rodriguez stated that there are residents that are not fully aware of how water contamination happened and graciously requested that the Board put on a public informational meeting to address their concerns. Joey from the city of Downey stated that he is concerned regarding the contamination of the water and would like people to take this seriously.

President Gonzales proceeded to the adoption of the Agenda. Vice President Caballero made the motion to adopt the Agenda. Director Martinez then requested that Item #8A – further extension of the mainline in Rosemead Blvd. be removed to another time. Due to a standing motion on the floor, President Gonzales seconded the motion to adopt the Agenda as written. The General Manager announced the motion to adopt the Agenda as presented passed by roll-call vote, 3-1 with Director Martinez voting "no".

President Gonzales proceeded to the next item on the Agenda, presentation by AKM Consulting Engineers on status of work to prepare bid specification to purchase and build new PFAS Treatment Systems for the District. Mr. Zeki Kayiran, P.E. informed the Board they are working on all required documents including, plans, specifications, estimates and an engineering report to be submitted to the Division of Drinking Water to address the treatment of PFAS chemicals for District Wells #5A, 8 and 11. The critical restraint facing this project is the number of water entities across the nation who are addressing this issue simultaneously and the availability of vessels for treatment to remove PFAS. It is their recommendation that these vessels be purchased in advance as soon as it is feasible as there is a 26-week lag time for production. If this can be done it is their belief that treatment can begin by the end of the year excluding a state mandate of 6 months of testing. Vice President Caballero stated he is pleased with the projected timeline. Director Martinez inquired as to who will inspect construction and then stated that he spoke with WRD and is happy to announce that the District is a recipient of funding assistance for the PFAS treatment systems. He further stated he spoke with Senator Robert Archuleta and was

informed that there are other monies available there as well. Director Martinez stated that he would get with the General Manager to go over this information.

President Gonzales proceeded to the approval of the Consent Calendar. Director Martinez made the motion to approve and Vice President Caballero seconded the motion. The General Manager announced the motion passed by roll-call vote, 4-0.

President Gonzales proceeded to the next item on the Agenda, consider further extension of the mainline in Rosemead Blvd. as part of the Beverly & Rosemead Boulevards Improvement Project. President Gonzales commented that the General Manager touched on this item at the last Board meeting and he has had the opportunity to go by the current area where the work is being performed and stated they are moving along pretty well as they are the only contractors in there at this time and this is the reason why he was not in favor of pulling this item as he feels time is of the essence. He further stated that being good stewards for the District there are some cost savings that can be realized by doing this now. The General Manager reviewed the project with the Board and the reason staff feels that now is the opportune time to perform the work. Director Ramirez expressed his support of this request as even with this additional work it is well below the bids by the other contractors for the original scope of work. Director Martinez stated he is concerned with this project as he feels since there is no traffic plan, no specifications or construction drawings, and there is no clue as to what is in the ground that this would be a good opportunity for the contractor to charge extras without a confirmative scope of work and he feels it is too big a liability for the District to take. Director Martinez made a motion to remove this item to a later time. Vice President Caballero asked the General Manager to elaborate on the issues presented by Director Martinez as he has done his homework on getting the project done. Director Ramirez asked to make a comment, but his call was dropped. The General Manager stated that Director Martinez makes very sound, valid points but it is because of those reasons that the District utilizes a preferred list of contractors. It has been the District's experience, through the relationships cultivated with these contractors that they do not "charge extras". With regard to J. DeSigio and the work they are doing now, this project has had items that were unknowns and through the relationship established they have been handled at little to no cost. There are projects that get done without plans and specifications, known as "Design and Build", and our engineers did review the county specs to determine what might be in the area, both a sewer and a gas line were notated, and neither one seems to be a problem. Potholing is scheduled to be billed as time and materials as the District did not know how long it would take to perform. At this time Director Ramirez was back on line and the General Manager deferred to him so he could continue with his comment. He stated that the District has been informed that everything in the ground in Rosemead was okay. The General Manager continued that the District feels comfortable and confident that there will not be anything detrimental as Director Martinez stated. The recommendation by District staff is that the District purchase the materials required for the work and the agreement with J. DeSigio be approved to install an additional 745 LF of ductile iron pipe, at a cost not to exceed \$229,045.00 which should more than cover the cost of unknowns, if there are any. Director Ramirez made the motion to approve and Vice President Caballero seconded the motion. The General Manager announced the motion passed by roll-call vote, 3-1, with Director Martinez voting "no".

President Gonzales proceeded to the next item on the Agenda, discuss the implementation of a new Capacity Charge. The General Manager introduced Erik Helgeson with Bartle Wells Associates to discuss the Capacity Fee Study that was done in conjunction with the rate study. He explained that Capacity Fees are one-time charges paid by new development of the area and the

benefit they receive, being their share of system capacity. He reviewed requirements under the Government Code, the methodology used to calculate fees, how capacity fee revenues can be used, and discussed how the Board would need to inform the public should they wish to move forward with this action. The General Manager reiterated that these fees will be paid by developers and property owners who may be developing a new or former piece of property. The collection of these fees will help to fund new CIP projects for distribution, new meter projects, and new well projects. Legal Counsel reiterated notice and hearing requirements and accounting and reporting requirements.

President Gonzales proceeded to the next item on the Agenda, General Manager's report. Work in Beverly Blvd. is moving very quickly and should be over at Layman Avenue by next week; notice of the Board vacancy has been posted as required.

President Gonzales proceeded to the next item on the Agenda, Legal Counsel report. SB 45, a climate resiliency bill, has been introduced providing a bond of \$5.5 billion for various environmental uses with several hundred million dollars of water related funded in it. SB 222 establish a low-income rate assistance program throughout the state. Counsel will be following both of these and will give updates as needed.

President Gonzales proceeded to the next item on the Agenda, Director's request for future agenda items. There were none.

President Gonzales proceeded to the next item on the Agenda, Director report on meetings attended. There were none.

President Gonzales proceeded to the next item on the Agenda, Director comments. President Gonzales stated that on more than one occasion the General Manager has had to call Board Members after 6:00 p.m. to inquire if they were attending the meeting. He feels as elected official it is important to be responsible and call in no later than 5:59 p.m. so meetings can begin as scheduled.

There being no further business to come before the Board, the Board meeting adjourned at 7:37 p.m.



Effective January 1, 2017, Assembly Bill 1794 directed me to implement the process for seating three representatives of water purveyors on the Board of Directors of Central Basin Municipal Water District. The implementation was completed in February 2017 by appointing one representative from the five largest purveyors, one representative from the cities that is a purveyor, and one representative from all purveyors within the District in accordance with the terms of the law. Enclosed for your information and reference is a copy of AB 1794 together with the rules for filling appointed positions on the Board of Directors of the Central Basin Municipal Water District. As a result of a disagreement during the initial nomination and appointment phase, Assembly Member Cristina Garcia introduced Assembly Bill 591. The bill provides clarification to Assembly Bill 1794, which created a new board governance structure of elected and appointed Board Members. Specifically, the bill defines "representative" as a consultant of an entity, a contractor of an entity, or a board member of an entity that is a mutual water company.

The bill was also amended to align the seating of appointed directors with that of elected directors on the first Friday in December. Additionally, the bill was amended to indicate that a nominee shall be employed by or a representative of the entity that puts forth their nomination. This bill was chaptered into law on July 30, 2019.

Effective, June 29, 2020, Mr. Dan Arrighi submitted his resignation from his position as Director on the Central Basin Municipal Water District Board. This being the case, there is a vacancy where there is a term of office remaining until February 2023. The seat that is up for selection is for:

• A Director to <u>represent all purveyors</u>, the vote of each purveyor shall be weighted to reflect the number of service connections the purveyor has within the District.

Enclosed is a form prepared for your use in making nominations. This form should be signed by the individual who is authorized by your entity to make the nominations and who will be authorized to vote on the nominations submitted. If you chose to not make any nominations, please indicate that decision by placing an "x" by that statement at the top of the form, complete the bottom portion of the form, sign and date the form and return it to our office on or before Tuesday January 5, 2021.

You are entitled to make a nomination for each category of purveyors for which you are eligible to vote. But you are not required to make a nomination for each category. If the person who will

be authorized to vote will be different from the person signing the nomination form, please provide a note on the form indicating who will be authorized to vote on behalf of your entity.

The nominee must not be in an elected office and must have a minimum of five previous years in one or more positions materially responsible for performing services relating to the management, operations, engineering, construction, financing, contracting, regulation, or resource management of a public water system. The nominee must not hold more than 0.5 percent ownership in a company regulated by the Public Utilities Commission.

It is important that you complete and return the nomination form at your earliest convenience. Although the legislation provides for a 60-day nomination period, as soon as I receive ALL nomination forms (not later than 60 days from today's date), I will prepare and send out the ballots.

Assembly Bill No. 1794

CHAPTER 401

An act to add Chapter 1.6 (commencing with Section 71265) to Part 3 of Division 20 of the Water Code, relating to municipal water districts.

[Approved by Governor September 21, 2016. Filed with Secretary of State September 21, 2016.]

LEGISLATIVE COUNSEL'S DIGEST

AB 1794, Cristina Garcia. Central Basin Municipal Water District. Existing law, the Municipal Water District Law of 1911, provides for the formation of municipal water districts and grants to those districts' specified powers. Existing law permits a district to acquire, control, distribute, store, spread, sink, treat, purify, recycle, recapture, and salvage any water for the beneficial use of the district, its inhabitants, or the owners of rights to water in the district. Existing law requires the board of directors of a district to consist of 5 members and each director to be a resident of the division from which the director is elected.

This bill would require the board of directors of the Central Basin Municipal Water District to be composed of 8 directors until the directors elected at the November 8, 2022, election take office, when the board would be composed of 7 directors, as prescribed. By imposing new duties on the district, this bill would create a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.

This bill would make its operation contingent on the enactment of SB 953 of the 2015–16 Regular Session.

The people of the State of California do enact as follows:

SECTION 1. Chapter 1.6 (commencing with Section 71265) is added to Part 3 of Division 20 of the Water Code, to read:

CHAPTER 1.6. CENTRAL BASIN MUNICIPAL WATER DISTRICT

71265. For the purposes of this chapter:

(a) "District" means the Central Basin Municipal Water District.

- (b) "Large water purveyor" means a public water system that is one of the top five purveyors of water as measured by the total purchase of potable and recycled water from the district for the three prior fiscal years.
- (c) "Public water system" has the same meaning as in Section 116275 of the Health and Safety Code.
- (d) "Relevant technical expertise" means employment or consulting for a total period of at least five years, prior to the date of first appointment, in one or more positions materially responsible for performing services relating to the management, operations, engineering, construction, financing, contracting, regulation, or resource management of a public water system.

(e) "Small water purveyor" means a public water system with less than

5,000 connections.

71266. (a) Except as provided in subdivision (c) and notwithstanding any other provision of this division, the board of directors of the district

shall be composed of seven directors as follows:

- (1) Four directors, one director elected for each division established pursuant to subdivision (d) by the voters of the division. Each director shall be a resident of the division from which he or she is elected. An election pursuant to this paragraph shall be in accordance with the Uniform District Election Law (Part 4 (commencing with Section 10500) of Division 10 of the Elections Code).
- (2) Three directors appointed by the water purveyors of the district in accordance with Section 71267.
- (b) The district shall be subject to Section 84308 of the Government Code.
- (c) Until the directors elected at the November 8, 2022, election take office, the board of directors shall be composed of eight directors as follows:

(1) Five directors in accordance with Section 71250.

- (2) Three directors appointed by the water purveyors of the district pursuant to Section 71267.
- (d) The board of directors shall divide the district into four divisions in a manner as to equalize, as nearly as practicable, the population in the respective divisions pursuant to Section 71540.
- 71267. (a) The general manager of the district shall notify each water purveyor of the district and provide a 60-day period during which the district will accept nominations for appointment of individuals to the board of directors.
- (b) Individuals nominated for appointment to the board of directors shall demonstrate eligibility and relevant technical expertise.
- (c) (1) The three directors appointed by the water purveyors shall be selected by the water purveyors of the district every four years as follows:
- (A) One director shall be selected by all large water purveyors from the nominees of large water purveyors. Each large water purveyor shall have one vote.
- (B) One director shall be selected by all cities that are water purveyors of the district from the nominees of cities. Each city shall have one vote.

(C) One director shall be selected by all of the water purveyors of the district from any nominee. The vote of each purveyor shall be weighted to reflect the number of service connections of that water purveyor within the district. If the selection of a director under this subparagraph would result in a violation of paragraph (2), the first eligible candidate receiving the next highest number of votes shall be selected.

(2) The appointment of directors pursuant to paragraph (1) shall not result

in any of the following:

(A) The appointment of three directors that are all employed by or representatives of entities that are all large water purveyors.

(B) The appointment of three directors that are all employed by or

representatives of entities that are all cities.

(C) The appointment of three directors that are all employed by or

representatives of entities that are all small water purveyors.

(3) Each nominee for director who receives the highest number of votes cast for each office described in paragraph (1) is appointed as a director to the board of directors and shall take office in accordance with Section 71512. The general manager shall collect the votes and report the results to the water purveyors. Votes for an appointed director are public records.

(d) Each appointed director shall live or work within the district.

(e) In order to ensure continuity of knowledge, the directors appointed at the first purveyor selection shall classify themselves by lot so that two of them shall hold office until the selection of their successors at the first succeeding purveyor selection and one of them shall hold office until the selection of his or her successor at the second succeeding purveyor selection.

(f) (1) The term of a director appointed pursuant to subparagraph (A) of paragraph (1) of subdivision (c) is terminated if the appointed director no longer is employed by or a representative of a large water purveyor.

(2) The term of a director appointed pursuant to subparagraph (B) of paragraph (1) of subdivision (c) is terminated if the appointed director no

longer is employed by or a representative of a city.

(3) The term of a director appointed pursuant to subparagraph (C) of paragraph (1) of subdivision (c) is terminated if the appointed director no longer is employed by or a representative of a water purveyor.

(g) (1) An appointed director shall not do any of the following:

(A) Hold an elected office.

(B) Hold more than 0.5 percent ownership in a company regulated by the Public Utilities Commission.

(C) Hold more than one consecutive term of office on the board.

- (2) An appointed director shall be subject to all applicable conflict-of-interest and ethics provisions and shall recuse himself or herself from participating in a decision that could have a direct material benefit on the financial interests of the director.
- (h) A vacancy in an office of appointed director shall be filled in accordance with the selection process described in subdivisions (a) to (c), inclusive.
 - (i) (1) An appointed director shall be eligible for all of the following:

(A) Reimbursement for travel and conference expenses pursuant to the Central Basin Municipal Water District Administrative Code.

(B) Compensation for up to 10 meetings per month at the per meeting rate provided by the Central Basin Municipal Water District Administrative Code.


(C) Health insurance benefits, if those benefits are not provided by the director's employer.

(2) An appointed director shall not be eligible to receive communication or car allowances. For purposes of this paragraph, "car allowances" does not include travel expenses incurred as described in paragraph (1).

(3) An appointed director may waive the reimbursement and compensation described in paragraph (1) and may be required to reimburse his or her employer for any compensation received.

SEC. 2. If the Commission on State Mandates determines that this act contains costs mandated by the state, reimbursement to local agencies and school districts for those costs shall be made pursuant to Part 7 (commencing with Section 17500) of Division 4 of Title 2 of the Government Code.

SEC. 3. This act shall only become operative if Senate Bill 953 of the 2015–16 Regular Session is enacted and becomes effective.

Summary

In March of 2019, Pico Water District (District) received Order No. 04-07-19M-005-1910125 from the State Water Resources Control Board (SWRCB), which was an order requiring the District to begin testing of its wells 5A, 8 and 10 for the presence of Perfluorooctanoic Acid (PFOA)/Perfluorooctanesulfonic Acid (PFOS) (collectively called PFAS chemicals) on or before June 30, 2019 and continue to sample quarterly for one year. At the time of receiving the new order from the SWRCB the Notification Level for PFOA was 14 Parts Per Trillion (PPT) and 13 PPT for PFOS; and the Response Level was a combined 70 PPT for both. On August 23, 2019, the SWRCB issued new guidelines which lowered the Notification Levels for PFOA from 14 PPT to 5.1 PPT and PFOS from 13 PPT to 6.5 PPT.

On July 31, 2019 Governor Newsom signed into law Assembly Bill 756 (see enclosed), which was a new law that would require any water agency that detects either PFOA or PFOS above the Response Level beginning in 2020 they would need to take significant steps to make sure that all customers are advised of the detection of PFAS chemicals in the water and the dangers associated with the consumption and use of the water. On February 6, 2020, the SWRCB lowered the Response Level (RL) for PFOA to 10 PPT and 40 PPT for PFOS, and stated that until another order was issued by the SWRCB that no further testing would be required by the water agencies as the SWRCB was planning to issue new orders for testing and PFAS compliance with AB 756, some time in 2020. This new guideline issued by the SWRCB significantly lowered the RL for these PFAS chemicals and based on previous testing of the District's three wells (5, 8 and 10) it was found that only wells 5 and 8 had detection of PFOA above the 10 PPT RL. In an effort to be make sure that all wells had been tested for the detection of PFAS chemicals staff tested well 4 and new well 11.

Based on the detection of PFAS chemicals at or above the RL in some of the District's wells the Board voted to begin discussion to build treatment systems at wells which had PFAS levels exceeding the RL. On June 3, 2020, the Board voted to hire AKM Consulting Engineers to provide engineering services related to the design and installation of PFAS treatment removal systems. On August of 2020 the SWRCB issued Order DW 2020-0003 a new order (see enclosed) requiring that the District now begin testing all of its wells again for one year and report the detection of

PFAS chemicals on a one-year average (see attached order). On September 30, 2020, the District submitted its application to the Water Replenishments District (WRD) of Southern California's "PFAS Remediation Program" for funding to build our planned treatment systems.

WRD has informed the water purveyors who applied for funding through their PFAS Remediation Program that they would be developing agreements between the WRD and those water agencies applying for funding and hoped to have those agreements sent out by early December 2020. However, due to issues with COVID-19 and other issues the agreements have taken longer than expected. I was recently informed by Diane Gatza the agreement should be out the week of January 25th, therefore I am placing the discussion of this agreement between the WRD and the District on the agenda in hopes that we will receive this item in time to discuss at our February 3, 2021 meeting.

Dear Mr. Grajeda:

Enclosed is Order No. 04_07_19M_005_1910125 (hereinafter "Order") issued by the State Water Resources Control Board ("State Water Board"), Division of Drinking Water ("Division") to the Pico WD. Please note that there are legally enforceable requirements associated with this Order.

The contamination of drinking water systems with per- and polyfluoroalkyl substances ("PFAS") has become an increasing concern due to the tendency of PFAS to accumulate in groundwater. Scientific studies indicate that exposure to PFAS can lead to significant health effects, especially in women who are pregnant or likely to become pregnant and in children. Of all PFAS compounds, PFOS and PFOA have been the most extensively produced and studied in the United States. Additional targeted testing needs to be completed to further identify the magnitude of the potential issue here in California.

From 2013 to 2015, the federal Third Unregulated Contaminant Monitoring Rule required all large water systems (water systems serving over 10,000 people) to collect and analyze more than 12,000 drinking water samples for PFOS and PFOA. In addition, some water systems serving less than 10,000 people reported approximately 400 drinking water results for PFOS and PFOA.

In May 2016, the United States Environmental Protection Agency (U.S. EPA) issued a lifetime health advisory for PFOS and PFOA for drinking water advising municipalities that they should notify their customers of the presence of levels over 70 parts per trillion of total combined PFOS and PFOA in community water supplies. U.S. EPA recommended that the notification of customers include information on the increased risk to health, especially for susceptible populations.

E. JOAQUIN ESQUIVEL, CHAIR | EILEEN SOBECK, EXECUTIVE DIRECTOR

The California Office of Environmental Health Hazard Assessment (OEHHA) recommends interim notification levels for PFOA (based on liver toxicity, as well as cancer risks) and for PFOS (based on immunotoxicity). Accordingly, on July 13, 2018, after independent review of the available information on the risks, the Division established notification levels at concentrations of 13 parts per trillion for PFOS and 14 parts per trillion for PFOA. These levels are consistent with OEHHA's recommendations.

Pursuant to Health and Safety Code section 116400, the Division is issuing the enclosed Order requiring testing for PFOA and PFOS along with all additional analytes using the Division approved testing methodology. As specified in the enclosed Order, your drinking water system sources that are specifically listed in the order are at risk for potential contamination by PFAS due to its proximity to adjacent facilities known to use, produce, or store PFAS. Any person who is aggrieved by this Order may file a petition with the State Water Board for reconsideration of this Order. Information regarding filing petitions may be found at:

ORDER REQUIRING THE PICO WD TO SAMPLE FOR PERFLUOROOCTANOIC ACID ("PFOA")/PERFLUOROOCTANESULFONIC ACID ("PFOS")

CALIFORNIA HEALTH AND SAFETY CODE SECTION 116400

The State Water Resources Control Board ("State Water Board"), acting by and through its Division of Drinking Water ("Division"), hereby issues Order No. 04_07_19M_005_1910125 (hereinafter "Order") pursuant to section 116400 of the Health and Safety Code to the Pico WD as set forth below:

AUTHORITIES

1. Health and Safety Code section 116400 authorizes the State Water Board, if it determines that a public water system is subject to potential contamination, to order a public water system to conduct periodic water analysis in accordance with conditions specified by the State Water Board. Section 116400 specifies that the water analysis shall be reported on a quarterly basis unless the State Water Board finds that reasonable action requires either more or less frequent analysis.

- 2. On July 13, 2018, pursuant to Health and Safety Code section 116455, the State Water Board: (1) established a notification level for perfluorooctanoic acid ("PFOA") at 0.000014 mg/L, and specified EPA Method 537 Rev. 1.1 as the analytical method; (2) established a notification level for perfluorooctanesulfonic acid ("PFOS") at 0.000013 mg/L, and specified EPA Method 537 Rev. 1.1 as the analytical method; and (3) established the response level for both PFOA and PFOS, combined, at 0.000070 mg/L.
- 3. Health and Safety Code section 116455 requires that within 30 days of a confirmed detection of a contaminant found in drinking water delivered by a public water system for human consumption that is in excess of a notification level set by the State Water Board, the public water system which supplies water directly to the end user shall notify the public water system's governing body and the governing body of any local agency whose jurisdiction includes areas supplied with drinking water by the water system. A local agency means a city and/or a county. If the water system is a water company regulated by the California Public Utilities Commission ("Commission"), then the water system shall also notify the Commission.
- 4. The drinking water system sources specifically listed in this Order are detected for per- and polyfluoroalkyl substances (PFAS) or at risk for potential contamination by PFAS due to proximity with adjacent source wells which are known to be contaminated with PFAS, as identified by testing conducted under the federal Third Unregulated Contaminant Monitoring Rule.

FINDING

Therefore, for the reasons set forth above, the State Water Board determines that the Pico WD is subject to potential contamination from PFOA/PFOS.

DIRECTIVES

THEREFORE, the State Water Board hereby orders that the Pico WD conduct periodic water analysis of PFOA/PFOS as follows:

 On or before June 30, 2019, collect a sample from the following sources to be analyzed for PFOA and PFOS. Samples shall be collected at least once each calendar quarter thereafter, and not less than for 4 quarters.

- 2. Samples collected pursuant to Directive 1 shall be analyzed using a laboratory accredited by the California Environmental Laboratory Accreditation Program (ELAP) for analysis of PFAS using either EPA Method 537.1 or EPA Method 537 Revision 1.1. The laboratory should conduct a complete analysis for all PFAS analytes under the method for which it is accredited. For EPA Method 537, Rev. 1.1, analysis for 14 analytes should be conducted. For EPA Method 537.1, analysis for 18 analytes should be conducted.
- 3. Due to concerns regarding contamination of samples by PFAS which may be present in clothing wom, fabric, lotions, sunscreen, food wrappers, etc., extra precaution must be used when collecting samples to avoid false positive results. You must consult with your laboratory to ensure that appropriate sampling protocol is followed. An example sampling protocol for PFAS developed by the Division is attached to this Order.
- 4. If laboratory analysis detects the presence of PFOA and/or PFOS in any sample above the notification levels, the Pico WD will have an option to conduct a confirmation sample within 30 days of being notified of the result by the laboratory.

If a confirmation sample is collected and analyzed, all results will be averaged within that quarter to determine if the confirmed detection is greater than the notification level. A result below the laboratory method reporting limit will be assigned a value of zero when averaging. If a confirmation sample is not collected, notification pursuant to Health and Safety Code section 116455 is required.

- 5. If a positive result for a source is followed by a result less than the laboratory method reporting limit, a second confirmation sample may be taken by the Pico WD within 14 days of the first repeat sample. A positive initial result will be disregarded if two additional samples do not show the presence of the organic chemical, pursuant to title 22, section 64445.1, subd. (c)(1) of the California Code of Regulations.
- Notification pursuant to Health and Safety Code section 116455 is required if, following the sampling and testing protocols set forth above, there is an exceedance of the notification levels for PFOA and/or PFOS in any of the listed source waters.
- 7. Notification pursuant to Health and Safety Code section 116455 is not required if, following an exceedance of notification levels for PFOA and/or PFOS, the Pico WD submits testing results following the sampling and testing protocols set forth above which shows that, following blending with another source or treatment, the water delivered to the customer does not exceed the notification levels for PFOA and/or PFOS.
- 8. The results of all analyses conducted pursuant to this Order shall be reported to the Board by the analyzing laboratory using the EDT (Electronic Data Transfer) process in accordance with section 64469 of title 22 of the California Code of Regulations. Analytical results shall be reported no later than the 10th day of the month following completion of the analysis.

State Water Board Updates Guidelines for Testing and Reporting PFOA and PFOS As It Assesses Scope of Problem

Process Begun for Establishing Regulatory Standards

SACRAMENTO – The State Water Resources Control Board today announced updated guidelines for local water agencies to follow in detecting and reporting the presence of perfluorooctanoic acid (PFOA) and perfluorooctanesulfonic acid (PFOS) in drinking water. The Board also announced it has begun the process of establishing regulatory standards for these chemicals.

The updated guidelines are part of the Board's comprehensive effort to assess the scope of contamination of drinking water supplies by PFOA and PFOS, chemicals that have been widely used in grease and stain-resistant coatings for consumer products and in firefighting foams. Because of their potential adverse health effects, these chemicals pose an emerging risk to drinking water sources nationwide.

The updated state guidelines lower the current notification levels from 14 parts per trillion (ppt) to 5.1 ppt for PFOA and from 13 ppt to 6.5 ppt for PFOS. The guidelines are based on updated health recommendations by the California Environmental Protection Agency's Office of Environmental Health Hazard Assessment (OEHHA).

Notification levels are a nonregulatory, precautionary health-based measure for concentrations in drinking water that warrant notification and further monitoring and assessment. Public water systems are encouraged to test their water for contaminants with notification levels, and in some circumstance may be ordered to test. If the systems do test, they are required to report exceedances to their governing boards and the State Water Board and are urged to report this information to customers.

In addition to the updated notification levels, the State Water Board announced today it has requested that OEHHA develop public health goals (PHGs) for both PFOA and PFOS, the next step in the process of establishing regulatory standards, known as maximum contaminant levels (MCLs), in drinking water. Other chemicals in the broader group of per- and polyfluoroalkyl substances (PFAS) may be considered later, either individually or grouped, as data permits.

The State Water Board is currently conducting a statewide assessment to determine the scope of contamination by PFAS, including PFOA and PFOS, in water systems and groundwater. In the first phase, public water systems were ordered earlier this year to sample about 600 drinking water supply wells located near airports and landfills, where contamination is more likely, and near locations where PFAS was previously found. These chemicals have been used in fire-fighting foams at airports for fire training and response and have also been used in many consumer products that end up in landfills.

Following this initial phase, the assessment will likely focus on sampling water sources near industrial sites and at wastewater treatment facilities. Data collected from the assessment will be made publicly available on the State Water Board's website and used to inform future actions.

While the State Water Board continues to assess the scope of contamination based on initial data reporting from the statewide assessment, the response levels for PFOA and PFOS remain at 70 parts per trillion for the total combined concentration of both contaminants, consistent with the U.S. Environmental Protection Agency's health advisory level. The response levels will be updated in the fall.

Response levels are nonregulatory, precautionary health-based measures that are set higher than notification levels and represent a recommended level that water systems consider taking a water source out of service or provide treatment if that option is available to them.

AB 756, signed by Governor Newsom on July 31, authorizes the State Water Board to more broadly order water systems to monitor for PFAS and report their detections. Additionally, drinking water sources with PFAS levels that exceed the response level are either to be taken out of service or the water system must provide public notice of the exceedance level. The law takes effect January 1, 2020.

Exposure to PFOA and PFOS can cause adverse health effects, including harmful effects to a developing fetus or infant, immune system and liver effects, and cancer. While consumer products are a large source of exposure to these chemicals for most people, drinking water has become an increasing concern due to the persistence and tendency of these chemicals to accumulate in groundwater.

ORDER DW 2020-0003-DDW

GENERAL ORDER REQUIRING MONITORING FOR PER AND POLYFLUOROALKYL SUBSTANCES CALIFORNIA HEALTH AND SAFETY CODE SECTION 116378

The State Water Resources Control Board ("State Water Board" or "Board"), acting by and through its Division of Drinking Water ("Division"), hereby issues General Order No. DW 2020-0003-DDW (hereinafter "Order") pursuant to section 116378 of the Health and Safety Code, as set forth below:

- WHEREAS, Assembly Bill 756 (2019-Garcia), approved by the Governor on July 31, 2019 and codified as Health and Safety Code section 116378, authorizes the State Water Board to require public water systems to monitor for per and polyfluoroalkyl substances ("PFAS"), in accordance with conditions set by the Board; and
- 2. WHEREAS, Health and Safety Code section 116378, subdivision (a) requires a laboratory that has accreditation or certification pursuant to Article 3 (commencing with section 100825) of Chapter 4 of Part 1 of Division 101 of the Health and Safety Code perform the analysis of any material required by an order issued pursuant to Health and Safety Code section 116378; and
- WHEREAS, an order issued pursuant to Health and Safety Code section 116378
 may apply to an individual public water system, specific groups of water systems,
 or to all public water systems; and

- 4. WHEREAS, pursuant to Health and Safety Code section 116378, Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code does not apply to an order issued to groups of public water systems or all public water systems; and
- 5. WHEREAS, Health and Safety Code section 116378, subdivision (c)(1) states that if monitoring results in a confirmed detection, then a community water system or a nontransient-noncommunity water system must report that detection in the annual consumer confidence report. Section 116378, subdivision (c)(1) further states that unless the water source is taken out of use or new data becomes available to show that the applicable response level is no longer being exceeded, the community or nontransient-noncommunity water system will provide notice of the exceedance of the response level in the water system's consumer confidence report; and
- 6. WHEREAS, Health and Safety Code section 116378, subdivision (c)(2) states that in addition to the notice required by subdivision (c)(1), for PFAS with notification levels, a community water system or nontransient-noncommunity water system must report a detection which exceeds the notification level as required by Health and Safety Code section 116455; and
- 7. WHEREAS, Health and Safety Code section 116378, subdivision (c)(3) states that for PFAS with response levels where detected levels of a substance exceed the response level, a community water system or nontransient-noncommunity public water system must take the water source out of use, provide treatment or blending of the source, or provide public notification as specified therein; and
- 8. WHEREAS, among other things, Health and Safety Code section 116455 requires that within 30 days of a confirmed detection of a contaminant found in drinking water delivered by a public water system for human consumption that is in excess of a notification level set by the State Water Board, the public water

- system which supplies water directly to the end user must notify the public water system's governing body and the governing body of any local agency whose jurisdiction includes areas supplied with drinking water by the water system. A local agency means a city or county. If the water system is a water company regulated by the California Public Utilities Commission ("Commission"), then the water system must also notify the Commission; and
- 9. WHEREAS, on August 22, 2019, pursuant to Health and Safety Code section 116455, the State Water Board: (1) updated the notification level for perfluorooctanoic acid ("PFOA") from 0.000014 mg/L to 0.0000051 mg/L, and specified EPA Methods 537.1 or 537 Rev. 1.1 as the analytical methods; (2) updated the notification level for perfluorooctanesulfonic acid ("PFOS") from 0.000013 mg/L to 0.0000065, and specified EPA Methods 537.1 or 537 Rev. 1.1 as the analytical methods; and
- 10. WHEREAS, on August 22, 2019, the Division requested the development of Public Health Goals (PHG) from the Office of Environmental Health and Hazard Assessment (OEHHA) for PFOA and PFOS; and
- 11.WHEREAS, on February 6, 2020, pursuant to Health and Safety Code section 116455, the State Water Board: (1) changed the response levels from a total combined PFOA and PFOS concentration of 0.000070 mg/l to 0.000010 mg/L for PFOA and 0.000040 mg/L for PFOS; and specified EPA Method 537.1; and
- 12. WHEREAS, during the first quarter of calendar year 2019, the State Water Board issued orders to select public water systems requiring monitoring for PFAS in drinking water supplies (2019 PFAS monitoring orders); and
- 13. WHEREAS, based on the review of the water quality monitoring results received from the 2019 PFAS monitoring orders, the Board has determined that it is necessary to expand monitoring to sources located within the vicinity of the PFAS detections; and

14. WHEREAS, by and through this Order, the State Water Board is exercising its authority under Health and Safety Code section 116378 to require those public water systems listed in Exhibit A to this Order to monitor for PFAS in accordance with the conditions set forth below.

THEREFORE, the State Water Board, by and through its Division of Drinking Water, hereby orders that the public water systems listed in Exhibit A to this Order monitor for PFAS as follows:

- On or before December 31, 2020, collect a sample from the sources listed in Exhibit A to be analyzed for PFAS. Samples must be collected at least once each calendar quarter thereafter.
- Samples collected must be analyzed using a laboratory accredited by the
 California Environmental Laboratory Accreditation Program (ELAP) for analysis
 of PFAS using EPA Method 537.1. The laboratory must conduct and report a
 complete analysis for all PFAS analytes under EPA Method 537.1.
- 3. A PFAS detection is a positive finding of a quantifiable amount above the established detection level requirement for any PFAS analyte tested pursuant to this Order. For the purposes of meeting the requirements in Health and Safety Code section 116378, the established detection level requirement for each PFAS analyte will be identified as the Consumer Confidence Report Detection Level (CCRDL). The detection level requirement for each PFAS constituent for which monitoring is required in this Order is identified by the State Water Board and attached to this Order.
- 4. If a laboratory reports the detection of PFAS in any sample at a concentration greater than the established detection level, the water system will have the option of collecting one or two confirmation samples within 30 days of being notified of the initial detected result by the laboratory.

- 5. If a PFAS detection is followed by a confirmation sample with a result less than the detection level, a second confirmation sample may be taken by the water system. Both the first and second confirmation samples must be collected within 30 days of the notification by the laboratory of the initial detected sample result. An initial detected result will be disregarded if both confirmation samples do not show the detection of the PFAS contaminant. If no confirmation sample or only one confirmation sample is collected, the initial detection must be presumed to be confirmed.
- 6. If the PFAS detection is confirmed, results of the initial and confirmation samples will be averaged within that quarter to determine if the confirmed detection is greater than the applicable notification level and/or response level. A result below the established detection level will be assigned a value of zero when averaging.
- 7. If the PFAS detection is confirmed, the detection must be reported in the water system's annual consumer confidence report.
- 8. If four consecutive quarters of testing results are below those listed on the CCRDL attached, the public water system may submit a request to their DDW District Engineer for a modification or reduction in monitoring.
- 9. If the results of a PFAS detection are confirmed to exceed a notification level, the water system must report the detection as required by Health and Safety Code section 116455. The section 116455 notification is required within 30 days after the water system is first informed by the laboratory of a confirmed detection of the contaminant that exceeds the notification level. As required by section 116455, if the public water system is a retail water system, then the person operating the retail water system must notify the retail water system's governing body and the governing body of any local agency whose jurisdiction includes areas supplied with drinking water by the retail water system. If the public water

- system is a wholesale water system, then the person operating the wholesale water system must notify the wholesale water system's governing body and the water systems that are directly supplied with that drinking water.
- 10. To determine whether monitoring shows an exceedance of a response level, the water system must calculate a quarterly running annual average (QRAA). The QRAA means the average of sample results taken at an individual source, treatment effluent, or delivered water locations for the identified source during four calendar quarters. The QRAA is re-calculated each quarter using the most recent four quarters of results. A single sample may result in the exceedance of the response level. If any sample would cause the QRAA to exceed a response level, the water source would be deemed to have exceeded the response level. If sampling has just begun and there are less than 4 quarters of results to average, then the other quarters will be considered to have a zero value and the quarterly results would be divided by four. If a system takes more than one sample in a quarter, the average of all the results for that quarter must be used when calculating the running annual average. If a system fails to complete four consecutive quarters of monitoring, the running annual average must be based on an average of the available data by dividing the available data by the number of quarters for which data is available.
- 11. If any monitoring undertaken pursuant to this Order results in a QRAA of PFAS in the water entering the distribution system that exceeds a response level, the water system must either (1) take the source out of service immediately;(2) utilize treatment or blending; or (3) provide public notification of the response level exceedance. Additionally, the exceedance of the response level must be reported in the annual consumer confidence report.

- 12. In addition to the sources listed in this Order, public water systems that provide treatment (example, blending, granular activated carbon, ion exchange or reverse osmosis treatment) can also sample the treated or delivered water to determine notification requirements. If treated water or delivered water samples are proposed to be collected, please contact the local DDW district office for input on sampling location and configuration.
- 13. Public notification for community or nontransient-noncommunity water system that are delivering water exceeding a response level must meet the requirements of Health and Safety Code section 116378 and either take the source out of use or complete the public notification requirements.
- 14. The results of all analyses conducted pursuant to this Order must be reported to the Board by the analyzing laboratory using the EDT (Electronic Data Transfer) process in accordance with Section 64469 of Title 22 of the California Code of Regulations. Analytical results must be reported no later than the 10th day of the month following completion of the analysis.

The State Water Board reserves the right to make modifications to this Order as it may deem necessary to protect public health and safety. Such modifications must be issued as amendments to this Order and must be effective upon issuance.

SEVERABILITY

The requirements of this Order are severable, and each public water system listed in Exhibit A must comply with each and every provision thereof notwithstanding the effectiveness of any provision.
